



TUITION RATES for Full Year Programs: Effective March 1, 2020

We offer a 7% discount for monthly payments and a 10% for quarterly payments using Bank Direct Debit (ACH). If you are interested in monthly or quarterly billing, please contact Andrew Sambrook at billing@annettespreschool.com or 914 441 8811. We offer an additional 10% sibling discount off the lowest tuition. **NEW for 2020!** Receive up to a 5% per child DCA employer matching discount. **We do not accept credit card payments. A one time, non-refundable registration fee is \$75 for all new families. We also require a refundable deposit equal to 1 week's tuition for weekly, 1/2 month for monthly and 1/2 Quarter for quarterly payors for new families or families changing tuition payment schedule.**

Birth to Three Program (6 weeks – Sept 1 after aged 3)

\$340 per week paid weekly full time **NOTE: Full Time enrollment only in the Infant (0-1) Program.**

\$1370 per month paid monthly on 1st of month. 7% discount over weekly rates, **(\$1240 savings per year! – weekly equivalent of \$316/week)**

\$3970 per quarter payable Mar 1, June 1, Sep 1, Dec 1. 10% discount over weekly rates, **(\$1800 savings per year! – weekly equivalent of \$305/week)**

\$85 per day for Birth to Three Programs (daily rate requires a minimum of 2 days) -- **same as 2019!**

\$685 per Month for enrolling 2 days/week (Monthly rate – 7% discount over weekly rates)

\$1025 per Month for enrolling 3 days/week (Monthly rate – 7% discount over weekly rates)

\$1990 per Quarter for enrolling 2 days/week (Monthly rate – 10% discount over weekly rates).

\$2985 per Quarter for enrolling 3 days/week (Monthly rate – 10% discount over weekly rates).

NOTE: Birth to Three rates will apply for children thru August 31 of the year preceding Preschool i.e. until they qualify for Act 166 funding as of September 1 after child is 3 years old.

Preschool Program (3 to 5 years) – Full Day Program

NOTE: Act 166 (Public PreK) funding of \$3445 for 2020/21 will cover 10 hours per week for all preschoolers who will be age 3 on or before September 1, 2020. This will automatically be applied during the school district year i.e. Weekly – over 42 weeks, Monthly – 10 months, Quarterly – 3 Quarters. For the remaining period (approx. June 15-Aug 31) an equal discount will be applied to provide a FLAT RATE billing structure and enable families to budget through the calendar year.

Weekly Payors! – a 52-week flat rate

“Out of pocket” Tuition of \$250 per week paid weekly AFTER credit for 2020/21 Act 166 funding of \$3445 or \$82.02/week. **If not eligible for Act 166 the full tuition rate of \$332.02/week will be applied.**

Monthly Payors! – a 12-month flat rate

“Out of Pocket” Tuition of \$1000 per month paid monthly on 1st of month AFTER credit for 2020/21 Act 166 funding of \$3445 or \$344.50/month. 7% discount for monthly billing, **(\$1000 savings per year! – Weekly equivalent of \$231/week).** **If not eligible for Act 166, the full tuition rate of \$1354.50/month will be applied.**

Quarterly Payors! – a 4-quarter flat rate

“Out of Pocket” Tuition of \$2925 per quarter paid quarterly on 1st of March/June/Sept/Dec AFTER credit for 2020/21 Act 166 funding of \$3445 or \$1148.33/quarter. 10% discount for monthly billing, **(\$1300 savings per year! – Weekly equivalent of \$225/week).** **If not eligible for Act 166 the full tuition rate of \$4073.33/quarter will be applied.**

Part-Week Option!

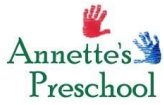
\$65 per day (part week PreK requires a minimum of 2 days) – AFTER credit for Act 166 funding - **same as 2019!**

\$525 per Month for enrolling 2 days/week (Monthly rate – 7% discount over weekly rates).

\$785 per Month for enrolling 3 days/week (Monthly rate – 7% discount over weekly rates).

\$1525 per Quarter for enrolling 2 days/week (Monthly rate – 10% discount over weekly rates).

\$2285 per Quarter for enrolling 3 days/week (Monthly rate – 10% discount over weekly rates).



TUITION RATES for Part Year Programs: Effective March 1, 2020

School Age Program (Ages 5 - 8) – School Year 2020/21 (limited to 20 participants!)

All Day HCS vacation/HCS in-service days (from Sept 1, 2020) **same rates as 2019/20!**

Winter and Spring Breaks	\$200/ 5 days
Other HCS Vacation and Inservice Days	\$ 40/ day

After School (2:30 dismissal from HCS: M, W, Th, Fr and 1:30 dismissal on T) **same rates as 2019/20!**

Daily	\$ 20/ day(min. 2 days)
Weekly	\$ 100/week
Monthly (charged at 4 x weekly rate)	\$ 400/month (M-F); \$80/ day.mo
Quarterly (10% off weekly)	\$ 1170/month, \$234/day quarter

The School Age Monthly rates are calculated at 4 x the weekly rates. This provides approximately a 7.5% discount. NOTE: The 7% monthly discount for our other programs is **NOT** additionally applicable to these rates.

Note: Summer Camp rates for the Summer 2020 season will be published in early Spring 2020.

Preschool Program (3 to 5 years) – AM Part Day Program

We require a one-time **returnable** deposit of \$250 and a **non-returnable** registration fee of \$75 upon registration for our Part Day program of 10 ¼ hours per week.

Minimum enrollment of 3-half days.(minimum of 10.25 hours/week) - **No “out of pocket” tuition charge to Families!**

NOTE: **Act 166 credits of \$3445 will cover the Tuition for 10 hours/wk of our 35-week program** for children who will be age 3 on or before September 1, 2020. This program follows the CVSD (Champlain Valley School District) school calendar.

Additional days will be charged as follows:

For enrolling **4 half days/week** -- **\$50/week** for 35 weeks or **\$163/month** for 10 months (Monthly rate – 7% discount over weekly rates) -- **same as 2019!**

For enrolling **5 half days/week** -- **\$75/week** for 35 weeks or **\$244/month** for 10 months (Monthly rate – 7% discount over weekly rates) -- **same as 2019!**

For those families that enter the program during the year but **do not** qualify for Act 166 funding, the tuition will be **\$150/week** or **\$490/month** for enrolling **3 half days/week**.
